## 3. Borrowing Rights and Responsibilities

- Students may borrow only one book at a time.
- Faculty members are allowed to borrow one book per subjects they teach per semester. The possibility of "Renewal" is subject to eventual request by other users. Books in the reserve section are not lent in to faculty members/ employees if these are badly needed by the students.
- Books in the General Circulation can be borrowed for one day. Fiction books can be borrowed for one week. However, if there is a great demand or request from other borrowers the books may be subjected for recall.
- General Reference books such as dictionaries, encyclopedias, atlases, manuals, and others, including newspapers, magazine and other journals are to be read inside the library only.
- Other researches or non-members of the MinSCAT community are required to pay fifty pesos (P50.00) as research fee for the use of materials or facilities and present a letter of permission and valid ID. All materials shall be for rooms use only.
- Borrowers are held responsible for all books charged to their names, including mutilation and / or defacement found inn library books when returned. Books must be checked and borrowers must report any mutilation found before borrowing.
